# **Fill-Out Instructions**

#### **General Instructions**

- > This form shall be filled out in handprinting and black ink.
- Should you have any inquiry, ask the Customs Personnel for assistance.
- The folio number shall be filled out by the customs officer receiving the form.
- Pursuant to the provisions of Article 9 of the Customs Law, any arriving or departing passengers who are bringing or taking money in cash and/or securities exceeding ten thousand American dollars or their equivalent in the currency at issue shall fill out the following fields: Section I: Passengers; Section II: Shipping, Courier and Securities-Custody Companies and others; Section III: Importers and Exporters.
- Everyone shall fill out Section IV.
- Upon filling out and signing the declaration, it should be handed to the customs personnel upon the passenger's arrival or departure.
- No declaration whatsoever shall be received if the name, date and signature are missing.
- The Declaration on Bringing and Taking Money in Cash and/or Securities may be requested to the customs
  personnel in charge at the departure or arrival ports within domestic territory or downloaded from www.satgob.mx.

Section I: Information on the Arriving or Departing Passenger Bringing or Taking Money in Cash and/or Securities

It must be filled-out by all arriving or departing passengers who bring or take money in cash and/or documents to or from Mexico on his/her own or on behalf of third parties.

Country (ies) of Citizenship: passenger must set out all citizenships he/she may hold.

Federal Tax ID Number or RFC: tax ID, code or number issued by the tax authorities of the country at issue.

Passport: set out the passport number and the issuing country; otherwise, set out ID type and number as well as the issuing country and authority

Visa: Indicate visa number



Section I.A: Information on the Person on Behalf of Whom Money in Cash and/or Securities are Brought or Taken

On your own: if the money in cash and/or securities are your own, you must indicate it here and fill out the following fields: Origin of the money in cash and/or securities brought or taken and Purpose of the money in cash and/or securities.

On behalf of third parties: if the money in cash and/or securities are owned by third parties, please fill out all the fields in Section I.A. The fields Origin of the money in cash and/or securities brought or taken and Purpose of the money in cash and/or securities should be filled out if you have been furnished with such information.



Section I.B: Information on the Place of Origin and Purpose of the Money in Cash and/or Securities

Information on the departure city and country and destination of the money in cash and/or securities. This section must be filled-out by those passengers who filled out Section I.



Section II: Information on Courier, Shipping and Securities-Custody Company and Others

This section must be filled out by courier, shipping, securities-custody companies and others.

Information on the Company Shipping Money in Cash and/or Securities

**Type of Shipping Company:** please specify whether it is a courier, shipping or securities-custody company or otherwise. In this case, please state type of company.

Date of sending: Indicate the date of sending of the securities and/ or notes receivable

Date of delivery: Indicate the date of delivery of the securities and/ or notes receivable.

Section II.A: Information on Sender or Recepient

#### Sender's Information

- Individual: set out family name, first name, middle name, date of birth, Federal Taxpayers ID Number or Code issued by the tax authorities of the country at issue of the individual who is sending money in cash and/or securities.
- Business Corporation: set out the corporate name and Federal Taxpayers ID Number or Code issued by the tax
  authorities of the country at issue of the business corporation that is sending money in cash and/or securities.

#### Recepient's Information

- Individual: set out family name, first name, middle name, date of birth, Federal Taxpayers ID Number or Code issued by the tax authorities of the country at issue of the individual who is receiving money in cash and/or securities.
- Business Corporation: set out the corporate name and Federal Taxpayers ID Number or Code issued by the tax
  authorities of the country at issue of the business corporation that is receiving money in cash and/or securities.

# Section III: Importation or Exportation Information

It should be filled out by the importer or exporter, as the case may be.

Importation: if its is an importation of money in cash and/or securities, set out the city and country of departure as well as the city or port of arrival.

Exportation: if its is an exportation of money in cash and/or securities, set out the city or port of departure as well as the city and country of arrival.

### Section III.A: Information on Customs Declaration

On the field concerning the Customs Declaration Number, please write down one number per box in order to complete 14 numbers, that is, the complete number of the Customs Declaration.

## Section IV: Information on Bringing or Taking Money in Cash and/or Securities

Means of Transportation: please specify the means of transportation used for bringing or taking money in cash or securities.

Maritime, air or land, as the case may be, and fill-out any additional information applicable to each case.

Concerning in-land transportation, please fill out the information in the **Driving Plates, Country and Issuing State** fields in case of private transportation.

**Information on money in cash and/or securities**: set out the precise amount in currency, notes, coins, documents or their combination as well as total number of currencies. If you are dealing with a currency different from US Dollars, MX Pesos or Euros, please specify on the **Currency** Column the type of currency and its country.

**Statement under Oath**: the signature must be affixed by hand or electronically if the Tax Administration Service has issued an Advanced Electronic Signature by the passenger, exporter or, if any, the attorney-in-fact. Concerning courier, shipping and securities-custody companies, the declaration must be signed by their attorneys-in-fact.

Official Use: This last section is for customs-use only.
